

### Revision of AXIS BANK VISTARA INFINITE Credit Card Terms and Conditions

With effect from 20<sup>th</sup> April '24, following revisions will be applicable on your **AXIS BANK VISTARA INFINITE** Credit Card:

**1. Revision of spends categories considered for earning Club Vistara Points and Milestone Benefit Calculation**

- In addition to the current category exclusions, Insurance and Gold / Jewellery transactions will not be eligible for earning Club Vistara points and achieving milestone benefits.

**2. Discontinuation of Concierge Services:**

- 24\*7 complimentary concierge services provided on your Axis Bank Vistara Infinite Credit Card will be discontinued

**3. Revision of Domestic lounge program (with effect from 1st May'24):**

- Your lounge access benefits will be based on your **AXIS BANK VISTARA INFINITE** Credit Card spends in the previous 3 calendar months.
- To access complimentary lounge from 1<sup>st</sup> May 2024 onwards, minimum spends required will be as follows:

<b>AXIS BANK VISTARA INFINITE</b> Credit Card	50,000	Previous 3 calendar months

- In case of a newly issued card, the minimum spend criteria is waived off for the month of issuance followed by the next 3 calendar months.
- For example, if card issuance date is 20<sup>th</sup> Mar 2024, you will be able to access lounge for the period 20<sup>th</sup> March to 30<sup>th</sup> June 2024, without any minimum spends. But if you want to avail lounge access after this period (in this case Jul 2024), then you will be able to do so only by spending Rs. 50,000 from 1<sup>st</sup> Apr to 30<sup>th</sup> Jun 2024 (preceding 3 months).
